Dr. P. Tudryn shared that the end of the school year went well. Graduation and middle school step up were well attended events. A. Wyse was recognized as Teacher of the Year and C. Rosa was recognized as Paraprofessional of the Year. Graduating seniors completed the annual grad walk and marked the milestone of the kindergarteners learning how to read. Additionally, WFSB aired a feature about the Romel twins who graduated as valedictorian and salutatorian.

X. OLD BUSINESS: DISCUSSION

- 1) Dr. P. Tudryn advised that an added appropriation in the amount of \$226,764 was approved by the Board of Selectmen to be presented to the Board of Finance. If approved it will be sent back to the Board of Selectmen to be voted on at a town meeting. Until the outcome of those votes, Dr. P. Tudryn and R. Galloway will be unable to present a budget for the Board to vote on. Discussion ensued regarding the FY2027 budget.
- 2) Chair D. Menard advised that the Ad Hoc Committee met and reviewed the information provided by Representative J. Foster. The consensus of the committee was to have the Board of Selectmen reestablish the committee in August for an additional 18 months. Discussion ensued regarding planning and next steps for the school renovations projects.
